##### **State Prize Laureate - Academic Legal Research- "Arab Republic of Egypt"- 2011/2012:**

The Prize was dedicated to Judge Dr. Mohamed A M Ismail for his distinguished legal research (books) in Arabic and English. **This is the highest award in academia in the Middle East and North African (MENA) region, since 1958.** The Panel which consists of the most six eminent professors in the MENA region decided to grant the Prize after scrutinizing Dr. Ismail's academic legal research which was submitted in Oct. 2010.

**PhD** in **International Construction Contract Arbitration, States' Contracts**. The Thesis discussed infrastructure Project Contracts in Egypt and developing countries adopting the civil law legal culture and containing foreign private entities.

- The main concern of the thesis is to prove the deterioration of ' *Le Contrat Administratif*' in civil law countries. This was done through examining the new legal nature of the contracts and arbitrations. The new conditions of the new administrative contracts were analyzed and concluded that the contracts have a new legal *hybrid* nature. This entailed the use of new mechanisms in the settlement of resulting disputes, particularly arbitration; in details ( both FIDIC form of contracts and ICC arbitration have a special significance in the study).

The second section is a complete comparative study to the common law jurisdictions (this was made possible by living in London for more than one year, as a student in the University of London).
